Eligibility Requirements

1. Open to the public. Applicant does not need to be a PFCU member; however selected scholarship recipients will need to meet Prime Financial membership requirements and open a Student Checking account to receive scholarship proceeds.
2. Applicant must be pursuing secondary education at an accredited 4-year, 2-year or technical school in the 2019-2020 school year.
3. Student must have a cumulative grade point average of 3.0 or above on a 4.0 point scale at the end of the first semester.
4. Must be a Class of 2019 graduating high school senior.
5. Recipients will participate in an award ceremony at the Annual Meeting and/or provide a photo for media use.
6. Application along with supporting documents must be complete, signed and returned to any PFCU branches by **May 1, 2019**. Applications may be emailed to marketing@primefcu.org or mailed to:

- 3. Letter of Recommendation** – Letter, with a signature, must be from a non-relative describing why you should receive this scholarship. We highly recommend education/business related letters to be printed on letterhead.
- 4. Official Transcript** – Transcript must include the name of the high school you are attending, your anticipated graduation date and cumulative GPA at the end of the first semester.
- 5. Personal Essay (Maximum 2 page, 12-point font, double space)** – Your essay must address the following topics:
 - o 1) Your academic, career or personal goals
 - o 2) Your contributions to your community such as volunteer work, assistance in community programs, etc.
 - o 3) How you plan to make a difference with your education
- 6. Proof of Acceptance/Enrollment:** This will be requested BEFORE scholarship recipients are selected.
